

Terms & Conditions – Rental Agreement



In consideration of the rental of products from this site, the undersigned (hereinafter referred to as the “customer”) from Shabby 2 Chic Wedding Rentals & Home Decor for the price outlined on this site the customer agrees to the following terms and conditions.

1. Reservations and Cancellations

A deposit of 50% is required upon the reservation of products. If products are cancelled within 180 days prior to the event, the deposit will be refunded less 25%. Some exceptions may apply. If a partial product is cancelled a 50% value of the cancelled product will be retained by Shabby 2 Chic Wedding Rentals & Home Decor. The remaining deposit will be applied to the remaining product rental. Refunds will not be issued from product returned unused. Any quantity adjustments on reserved product are to be made twenty-one (21) days prior to the scheduled pick up date.

2. A security deposit is required on all product orders. This may be done in the form of accepted credit card, cash, visa, master card or direct debit.
3. The rental term will begin on the date specified as the date the order is placed and ends on the date the items are scheduled to be returned. The customer agrees to arrange delivery of product to the premises of Shabby 2 Chic Wedding Rentals & Home Decor on or before the pickup date unless granted otherwise. The customer also agrees to pay late charges for product after the scheduled pickup date. The amount of late charge will be determined by Shabby 2 Chic Wedding Rentals & Home Decor.
4. Upon the initial reservation of your items and the rental contract is signed, an initial deposit of 50% of the rental cost is required. The final 50% payment is due two weeks prior to event or if you require delivery to the event, final payment is required three weeks prior to the event.
5. We will honor refunds less 25% if you decide to cancel 180 days before your event. If within the 180 days, the full deposit will be retained. If the contract is cancelled within a week of event, the full order amount will be retained.

6. Damage Protection

The Customer accepts the responsibility for all damages and will reimburse Shabby 2 Chic Wedding Rentals & Home Décor the value to be determined by Shabby 2 Chic Wedding Rentals & Home Décor for any cause other than those set out below in paragraphs A, B, C and D for which the customer will be fully responsible and liable with respect to each item rented.

- A. Loss or damage due to theft, disappearance, or shortage of product returned to the premises of Shabby 2 Chic Wedding Rentals & Home Décor.

- B. Loss or damage due to infidelity of the customer, employees, or persons who are entrusted with the product.
- C. Loss or damage due to improper handling or transportation.
- D. Loss or damage due to customer breaching section 6 of this rental agreement.

7. Cleaning Charges

The security deposit will be charged for any items returned unclean.

8. Customer's liability for loss or misuse of product

The customer shall not permit any repairs to be made or lien to be placed upon the product rented without the consent of Shabby 2 Chic Wedding Rentals & Home Decor. In the event of any accident or incident causing bodily harm or injury or property damage as a result of use or the renting of product from Shabby 2 Chic Wedding Rentals & Home Decor, the customer agrees to accept full responsibility and shall indemnify and save harmless Shabby 2 Chic Wedding Rentals & Home Decor arising from any actions, claims, suits, or judgements which may arise from the use, transport, or storage of equipment. The customer also further agrees to pay all legal costs incurred by Shabby 2 Chic Wedding Rentals & Home Decor, its employees in defending such action, claim suit or demand. In the event of Loss or Destruction, or loss of possession, or unable to return the product to Shabby 2 Chic Wedding Rentals & Home Decor on the scheduled return date for any reason, the customer agrees to pay Shabby 2 Chic Wedding Rentals & Home Decor the actual replacement cost of the product.

9. Disclaimer

Shabby 2 Chic Wedding Rentals & Home Décor makes no warranties, express or implied, as to the products fitness for any particular purpose. Shabby 2 Chic Wedding Rentals & Home Decor shall not be responsible for any loss, damage, or injury to customer's property including incidental, special, or consequential damages, in anyway, connected with the operation, use, defect in or failure of product.

10. Delivery/Pickup

This service is available to customers for a \$50.00 fee each way within Edmonton and surrounding areas unless otherwise arranged. There will be a fee for any additional mileage for deliveries outside of Edmonton area based on location and size of crew. Deliveries will be placed next to the entrance way. All product rented will be the responsibility of the customer until Shabby 2 Chic Wedding Rentals & Home Decor takes physical possession of.

- 11. The customer hires the product for rent on an "as is" basis. The customer acknowledges receipt of product in good working order. The customer agrees on the product count on receipt of product. Any shortages or discrepancies must be reported to Shabby 2 Chic Wedding Rentals & Home Decor prior to the start of the event. Any messages via email or answering machine will be deemed improper notification.
